REVISION TO THE MERCER COUNTY, MONMOUTH COUNTY, TRI-COUNTY, UPPER DELAWARE, AND UPPER RARITAN WATER QUALITY MANAGEMENT PLANS

TAKE NOTICE that on pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Mercer County, Monmouth County, Tri-County, Upper Delaware, and Upper Raritan Water Quality Management (WQM) Plans was adopted by the Department. This revision updates the digital sewer service area (SSA) mapping to correct minor errors within the mapping so that it is consistent with the appropriate adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1.

Within the Mercer County WQM Planning Area in Hopewell Township, Mercer County a correction has been made to correctly identify the SSA of Bristol Meyers Squibb (NJ0000795) located on Block 46, Lot 8.01. The SSA is limited to within the internal Loop Road area, located in the northeast portion of the property, with the exception of the proposed day care building as identified in an amendment to the Hopewell Township WMP that was adopted September 24, 2001.

Within the Mercer County WQM Planning Area in Hopewell Township, Mercer County a correction has been made to the SSA of the Stony Brook Regional Sewerage Authority (SBRSA) Pennington Sewage Treatment Plant (STP) (NJ0035319) located on Block 46, Lot 19.01. The parcel was previously incorrectly labeled as SBRSA Hopewell STP and has been correctly relabeled SBRSA Pennington STP as depicted in the Pennington Borough WMP that was adopted March 27, 1992.

Within the Monmouth County WQM Planning Area in the Borough of Tinton Falls, Monmouth County a correction has been made to correctly identify the SSA of the Township of Neptune Sewerage Authority STP (NJ0024872) as depicted in the Monmouth County WQMP.

Within the Monmouth County WQM Planning Area in the Township of Upper Freehold, Monmouth County a correction has been made to correctly identify the SSA of the Allentown Borough Wastewater Treatment Plant (WTP) (NJ0020206) as depicted in the Upper Freehold WMP that was adopted October 29, 1998.

Within the Tri-County WQM Planning Area in Elmer Borough, Salem County a correction has been made to correctly identify the South Jersey Hospital – Elmer SSA (NJ0099571) as identified in a revision to the Tri-County WQM Planning area that was adopted March 31, 1998.

Within the Upper Delaware WQM Planning Area in Frelinghuysen Township, Warren County a correction has been made to correctly identify the SSA of the Johnsonburg Presbyterian Camp (NJ0067857), James Alexander Corporation (NJG0116696), Johnsonburg Wastewater Treatment Facility and the Westbrook Realty/Westbrook Farms Industrial Park as identified in the Frelinghuysen Township WMP that was adopted January 14, 1997.

Within the Upper Delaware WQM Planning Area in Knowlton Township, Warren County a correction has been made to correctly identify the SSA of the Knowlton WTP (NJ0134864) as depicted in the Knowlton Township WMP that was adopted May 22, 1999.

Within the Upper Raritan WQM Planning Area in Montgomery Township, Somerset County a correction has been made to correctly identify the boundaries of the SSA of the Pine Brook STP (NJ0060038) as depicted in the Montgomery Township WMP that was adopted June 1, 2001.

Within the Upper Raritan WQM Planning Area in Montgomery Township, Somerset County a correction has been made to include a designated DGW service area. The St. Charles Borromeo Church has an approved planning flow of 3,929 gpd as identified in an amendment to the Upper Raritan WQM Planning area that was adopted February 11, 2003.

Within the Upper Raritan WQM Planning Area in Mount Arlington Borough, Morris County a correction has been made to correctly identify the SSA of the United Water Mid-Atlantic (Arlington Hills) STP (NJ0065226) as depicted in the Mount Arlington Borough WMP that was adopted March 2, 2000.

Within the Upper Raritan WQM Planning Area in Mount Arlington Borough, Morris County a correction has been made to add Block 61, Lot 17 (Pennington Woods Development) to the SSA of the Musconetcong STP (NJ0027821) as identified in an amendment to the Upper Raritan WQM Planning area that was adopted September 6, 2002.

Within the Upper Raritan WQM Planning Area in Roxbury Township, Morris County a correction has been made to areas that were previously incorrectly labeled as United Water Mid-Atlantic (Arlington Hills) SSA. These areas have

been correctly relabeled DGW less than 20,000 gallons per day (gpd) as identified in the Roxbury Township WMP that was adopted May 22, 1996.

A correction to the NJPDESFL field in the SSA attribute table has been made to reflect the current NJPDES permitted flow rates.
