Dear Ms. Conklin:

Please be advised that, pursuant to the provisions of the Water Quality Planning Act (N.J.S.A. 58:11A-1 et seq.) and the Statewide Water Quality Management Planning rules (N.J.A.C. 7:15-3.5), the Department of Environmental Protection (Department) has processed a WQMP revision for the above referenced project.

This revision corrects/updates the Department's digital coverage of adopted wastewater service areas for the Highlands preservation area adopted on October 6, 2006 to identify Lots 7, 7.01 and 8 in Block 205 of Wanaque Borough, Passaic County as sewer service area of the Wanaque Valley Regional Sewerage Authority (WVRSA) Sewage Treatment Plant (STP). That area was, in fact, not removed from sewer service area identified in the adopted Wanaque Borough WMP by the Highlands Water Protection and Planning Act (Highlands Act) since a sewer collection system had been installed prior to August 10, 2004, the date of enactment of the Highlands Act. Two of the properties are currently being served by the WVRSA STP and the Conklin property demonstrated with valid documentation that the proposed project on Lot 7.01, Block 205 is exempt from the Highlands Act and thus is eligible to receive sewer service.

Enclosed is a copy of the Department's notice approving the WQMP revision. A copy of this notice should be submitted with any Treatment Works Approval application. If you, as a recipient of a copy of this letter, are the Designated Planning Agency or the Wastewater Management Planning agency for this area, please continue to identify these properties as sewer service area of the WVRSA STP in your copy of the Northeast WQMP/ the Borough of Wanaque WMP.

REVISION TO THE NORTHEAST WATER QUALITY MANAGEMENT PLAN

JAN I 5 2013 TAKE NOTICE that on , pursuant to the provisions of the Water Ouality Planning Act, N.J.S.A.58:11A-1 et seq., and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision affecting the Northeast Water Quality Management Plan (WQMP)/Borough of Wanaque Wastewater Management Plan (WMP) was adopted by the New Jersey Department of Environmental Protection (Department). This revision updates the digital sewer service area mapping for the Highlands preservation area adopted on October 6, 2006 to identify the Conklin property located on Block 205, Lot 7.01 in Wanaque Borough, Passaic County as sewer service area of the Wanaque Valley Regional Sewerage Authority (WVRSA) Sewage Treatment Plant (STP). Furthermore, this revision also updates the digital sewer service area mapping by identifying Lots 7 & 8, Block 205, in Wanaque Borough, Passaic County, as sewer service area of the WVRSA STP. The adopted Wanaque Borough WMP already identifies these three parcels as existing sewer service area.


In accordance with N.J.S.A. 58:11A-7.1 of the New Jersey Water Quality Planning Act, the Department adopted an amendment on October 6, 2006 revoking previously designated sewer service area in the Highlands preservation area for which wastewater collection systems had not been installed as of August 10, 2004, the date of enactment of the Highlands Water Protection and Planning Act, N.J.S.A. 13:20-1 et seq. (Highlands Act). This revocation, however, did not extend to any designated sewer service area necessary to serve development in the Highlands preservation area that is exempt from the provisions of the Highlands Act pursuant to N.J.S.A. 13:20-28 or to areas already receiving sewer service.

The Conklin property located at Block 205, Lot 7.01 demonstrated with valid documentation that a sewer line had been installed to serve this property prior to August 10, 2004 and that the proposed project on this property is exempt from the Highlands Act. Additionally, documentation was submitted verifying that Lots 7 and 8, Block 205 were already being served by the WVRSA STP. Therefore, in accordance with N.J.A.C. 7:15-3.5(b)1, the Department has determined that Lots 7, 7.01 and 8, Block 205 in Wanaque Borough qualifies for a revision to correct, clarify, or update erroneous, unclear, or outdated statements in an areawide WQMP. This area, therefore, is now identified as sewer service area in the Department's digital sewer service area mapping and remains identified as sewer service area in the Wanaque Borough WMP. This mapping correction is authorized as a revision pursuant to N.J.A.C. 7:15-3.5(b)1.
