

General Definitions

- 1. "Store" is any grocery store, convenience store, liquor store, pharmacy, drug store or other retail establishment
- 2. "Food Service Business" sells or provides food for consumption on or off the premises, including establishments such as a restaurant, café, delicatessen, coffee shop, convenience store, grocery store, vending truck or cart, food truck, movie theater, or business or institutional cafeteria, including those operated by a government entity
- 3. "Grocery Store" is a self-service retail establishment that occupies at least 2,500 square feet and sells household foodstuffs for off-site consumption
 - It does not include an establishment that handles only pre-packaged food that does not require time or temperature controls for food safety

Single-use Bag Ban Definitions

- o "Plastic" means a synthetic material made from linking monomers through a chemical reaction to create an organic polymer chain that can be molded or extruded at high heat into various solid forms retaining their defined shapes during the life cycle and after disposal
- "Single-use plastic carryout bag" means a carryout bag made of plastic that is not a reusable carryout bag
- "Single-use paper carryout bag" means a carryout bag made of paper that is not a reusable carryout bag
- "Reusable carryout bag" means a carryout bag that:
 - Is made of polypropylene, PET nonwoven fabric, nylon, cloth, hemp product, or other machine washable fabric
 - Has stitched handles; and
 - o Is designed and manufactured for multiple reuse

Bag Exemption Questions

Single-use carryout Bag Exemptions

- A bag used solely to contain or wrap uncooked meat, fish, or poultry;
- A bag used solely to package loose items such as fruits, vegetables, nuts, coffee, grains, baked goods, candy, greeting cards, flowers, or small hardware items;
- A bag used solely to contain live animals, such as fish or insects sold in a pet store
- A bag used solely to contain food sliced or prepared to order, including soup or hot food
- A laundry, dry cleaning, or garment bag
- A bag provided by a pharmacy to carry prescription drugs
- A newspaper bag
- Any similar bag, as determined by the department pursuant to rule, regulation, or guidance.

Alternatives to Plastic Questions

"Plastic" means a synthetic material made from linking monomers through a chemical reaction to create an organic polymer chain that can be molded or extruded at high heat into various solid forms retaining their defined shapes during the life cycle and after disposal

The Department will not be able to approve alternative plastic on a case-by-case basis; Businesses may have to decide for themselves if their product meets this definition or not, and what information is needed for this decision.
